Disagree – For inclusion ICH should be able to demonstrate a degree of permanence. To quote the Convention itself: *This intangible cultural heritage, <u>transmitted from</u> <u>generation to generation</u>. Therefore, we would propose that, to be included within the definition of ICH, there should be proof that the practice is a minimum of 30 years old. A period of 30 years would represent a standard definition of a generation; would align with definitions of tangible heritage; and would also imply a degree of permanence for the practice in question.* 

### • The Intangible Cultural Heritage can originate from anywhere.

• The Intangible Cultural Heritage must be a living practice and can not be a material product or object.

Agree – It will be important, when considering safeguarding, to understand and reflect the important relationship that ICH has with tangible heritage. Whilst the ICH itself can not be a material product, object, structure or place, some, each or all may play a vital role in the practice itself and so will need to be understood and reflected in any safeguarding measures.

Disagree - We feel that categories do not fully capture some elements of ICH, in particular expressions of the relationship people have with **places** and how they have been shaped by previous generations. For example, it isn't clear where, within the current categories, land management practices (e.g. commoning) could be included on the proposed Inventory. We would suggest that the category 'knowledge and practices concerning nature and the universe' is widened to explicitly references the inclusion of practices that relate directly to people's relationship with the wider environment. An alternative form of words could be 'knowledge and practices concerning places, the environment and the universe.'
